

SUMMARY ANNUAL REPORT LOCAL 138, 138A & 138B LEGAL FUND

This is a summary of the annual report for the Local 138, 138A & 138B Legal Fund, EIN 11-2428038, Plan No. 501, for the period July 1, 2014 through June 30, 2015. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$351,682 as of June 30, 2015, compared to \$485,059 as of July 1, 2014. During the plan year the plan experienced a decrease in its net assets of \$133,377. This decrease includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$244,346 including \$244,146 from employer contributions and earnings from investments of \$200.

Plan expenses were \$377,723. These expenses included \$53,723 in administrative expenses and \$324,000 in benefits paid to participants and beneficiaries.
